## **Instructions**

- 1. This is a PDF form. It can be printed and hand filled. It must be printed and signed prior to submission.
- 2. This application must be approved by a member of the Unit Executive of the Unit being joined.
- 3. The completed form must be forwarded to the Unit in which membership is being sought along with the applicable fees and dues. Initial joining package and National dues are the same for all Units but each Unit may have their own dues.
- 4. The completed application must be signed by the applicant under both the "Oath" and "Waiver", prior to submission.

**Veterans please note**: Proof of service must be provided together with your application. Failure to provide proof of service will not exempt you from membership but will allow you to join as a supporter only. Proof of service can be a scanned document such as a course certificate, 490A, UER training records, record of service card, course photo etc etc. This certification is subject to approval by both National and the Unit exec. Please also note:

## Unlawful use of military uniforms or certificates

- 419. Every one who without lawful authority, the proof of which lies on him,
- (a) wears a uniform of the Canadian Forces or any other naval, army or air force or a uniform that is so similar to the uniform of any of those forces that it is likely to be mistaken therefor,
- (b) wears a distinctive mark relating to wounds received or service performed in war, or a military medal, ribbon, badge, chevron or any decoration or order that is awarded for war services, or any imitation thereof, or any mark or device or thing that is likely to be mistaken for any such mark, medal, ribbon, badge, chevron, decoration or order,
- (c) has in his possession a certificate of discharge, certificate of release, statement of service or identity card from the Canadian Forces or any other naval, army or air force that has not been issued to and does not belong to him, or
- (d) has in his possession a commission or warrant or a certificate of discharge, certificate of release, statement of service or identity card, issued to an officer or a person in or who has been in the Canadian Forces or any other naval, army or air force, that contains any alteration that is not verified by the initials of the officer who issued it, or by the initials of an officer thereto lawfully authorized, is guilty of an offence punishable on summary conviction.
